Happy Holidays everyone! This time of year means that our 2011 budgets have been finalized and the ASPPPO membership and CSA assessment bills will be in the mail very soon. 2010 has been a very busy and successful year for CSA and 2011 will be more of the same. Now, for some updates.

Holiday Closings. The CSA, ASPPPO, and ARB offices will be closed on Thursday and Friday, November 25 and 26. We will be closed for the Christmas holiday on Thursday, December 23 and Friday, December 24. We will also be closed on December 31 for New Years Eve. The Security Dispatch office will remain open 24 hours a day, 7 days a week as always. Please check our website at, seapinesliving.com for this and other important information.

Mailboxes and House Number Signs. I ask everyone to please take a look at your mailboxes and house number signs to ensure they are in a good state of repair. Also, this time of year, wasps and bees tend to nest in mailboxes, so as a safety precaution, it is suggested to check for them too.

The house number signs are replaced by CSA at no charge. There is a small fee for mailboxes and posts. Both of these can be ordered via our website, seapinesliving.com or by calling (843) 671-1343. We have made a lot of progress in these areas, but still have a way to go to get everyone up to standards. Thank you!

**CSA Security Update.** It is important to remain vigilant during the season of giving. With few exceptions, property thefts in Sea Pines are "crimes of opportunity and access". That can be an unlocked door, a key or access provided to a vendor when no one is at home, or Christmas presents visible to the outside. Regardless of where you park your locked vehicle, never leave Christmas packages or valuable items in plain sight where a passing thief may be tempted.

Enjoy this season of giving, but remain alert to those who may wish to exploit your generosity. Solicitation of any kind is not permitted in Sea Pines. If someone comes to your door in an attempt to solicit a Christmas contribution, try to note the vehicle or person's description and call Sea Pines Security immediately (843) 671-7170.

### Csa Requests Your Input On The Proposed Restatement AND REVISIONS TO SEA PINES GATE ENTRY POLICY

Did you know that gate entry fees make up about 30% of the annual Sea Pines budget, approximately \$2.7 million annually? And did you know that there are 42 different kinds of gate entry decals and passes that our security officers must identify?

In an effort to make the policy more easily understood, the CSA Board has endorsed a draft Restatement of Sea Pines Gate Entry Policy. Consonant with our goal of transparency, the draft is posted on our website, seapinesliving.com (go to the News and Announcements page) for your review prior to its final approval and implementation.

Gate entry privileges and restrictions influence perceptions of our Sea Pines community and they are a significant source of revenue. We urge you to take a look at the proposed Restatement. We need your comments or questions by November 15. Your input is important. ### SEA PINES VOLUNTEER BOARDS KEY TO MANAGING COMMUNITY

The ambiance, beauty and amenities that make Sea Pines such a desirable place to live are the result of continuing work by Sea Pines property owner volunteers through the ASPPPO and the CSA boards and the Architectural Review Board (ARB).

The Association of Sea Pines Plantation Property Owners (ASPPPO) was established in 1974 to represent "the interests of the residential property owners" in protecting rights under the Plantation's Land Use Covenants. Its most basic functions are to enforce compliance with the covenants and to provide you, the residential property owner, with a place to voice your opinions and get answers to your questions. The Association is managed by an elected board of directors composed of



nine property owner representatives, and is funded through voluntary membership dues. Dues cover administrative expenses, legal services for the defense of the covenants and newsletter expenses. By being a member of ASPPPO, owners ensure these important responsibilities will be carried out.

Community Services Associates (CSA), a not-for-profit organization, was incorporated in 1988 to take title to all common properties in Sea Pines including the open space, roads and lagoons and to provide security and maintenance services. CSA has a fine paid management staff, excellent security personnel and an outstanding maintenance crew. Staff maintains the roads, open spaces and bike paths, plants flowers, provides security, maintains the lagoons and storm drainage, and operates the Community Center. CSA is managed by a board of directors which includes nine elected residential property owners, four appointed Sea Pines Resort representatives, and four elected commercial property owner representatives.

Perhaps the highest profile management entity in Sea Pines is the **Architectural Review Board (ARB)** which reviews and approves or disapproves plans for all new structures and any alterations or additions to structures and plans for landscaping, drainage and tree removal. The ARB was established in the covenants and its functions are central to Sea Pines' original premise that development would be strictly controlled. ARB consists of nine volunteer members, three appointed by The Sea Pines Resort, two appointed by the CSA Board, two appointed by ASPPPO and two alternate members.

In this issue, you will find information about your neighbors who have volunteered to run for the CSA and ASPPPO boards. These are demanding, time-consuming jobs and we are fortunate to have individuals who are willing to serve.

Among many challenging issues currently facing the boards are ensuring the long-term viability of the Sea Pines harbors; identifying, prioritizing and implementing a 5-10 year plan for upgrading and refreshing Sea Pines facilities; and articulating a broad strategic plan for Sea Pines' future. These are issues in which we all have a stake, so please take the time to study the background information and please VOTE to ensure that your voice is heard in the governance of our beautiful and special community.


#### Are You A Budding Nature Photographer?
