From the Desk of Cary Kelley



Hello, everyone! I hope everyone had a safe and enjoyable summer. I have a few things I would like to make you aware of at this time.

Forest Preserve Improvements - This spring the Forest Preserve Foundation approved implementing recommendations to improve the fish habitat in all the lakes in the Forest Preserve. The recommendations were the result of a study that was completed in May of this year by an outside fishery management group. Total implementation will not be completed until early in 2010, but several improvements have been made this year. These include installation of aerators to help improve the overall oxygen levels, stocking of grass carp to help reduce algae levels, implementation of a more effective fertilization program, several brush piles have been placed along the

lake edges along with several fish attractors to provide cover for the brim, and finally an outdoor chapel was located on Fish Island. The chapel was actually an Eagle Scout project. Our local boy scouts did most of the work involved with the last two improvements and we look to complete several more projects with their help in the future. Very soon you will be receiving the Foundations annual donation letter which will include the list of projects to come. Please take the time to review the material and help us improve this wonderful Sea Pines resource.

Recycling Drop Off Center: - CSA has looked at the possibility of having a drop off site for all our members to use in Sea Pines, but so far, we have not been able to locate a site that would meet our needs and not create a visibility/noise/traffic problem for the adjoining property owners. The Town of Hilton Head is currently considering requiring that trash vendors operating within the Town limits provide recycling pick up to all residents. This issue is still being considered and as additional information becomes available we will share it with you. At this time, the only drop off point for our owners is at the Convenience Recycling Center located off of Dillon Rd - just follow the signs.

Fall Road Paving - The repaving of Greenwood Drive from Fraser Circle south to Sea Pines Drive will begin in mid-September and finish in early October. Please be careful when driving in this area while work is being done and please obey all posted speed limits and safety signs.

Encroachment into CSA Open Space - Sea Pines Property Owners are reminded that any encroachment into CSA Open Space/Property requires prior CSA Board approval. Any encroachment whether vegetative or structural **requires CSA Board approval** and in most instances ARB approval. The Encroachment Policy is posted on the CSA website www.csaseapines.com for your review or you can call the CSA office at 671-1343 for information and answers to any questions that you may have. Please do not do any work without prior approval by the CSA Board.

In closing, 2008 has been another successful year for CSA. The Board of Directors and all of the committee members have worked hard to ensure our community continues to set the standard on Hilton Head Island. These volunteers put in an enormous amount of time helping staff identify and focus on what is important to our members. If you have the opportunity, please take the time to thank those serving this community. HELP WANTED!


Sea Pines is looking for volunteers to serve on its Architectural Review Board. This involves important work and would require attending a weekly meeting.

SEA PINES SECURITY UPDATE



George Breed, Director of Sea Pines Security, recently announced that year to date total crime reports in Sea Pines for 2008 reflect a 33% reduction from reported incidents in 2007. He feels this is the result of the department's recent proactive enforcement programs along with coordinated efforts with the BCSO on several investigations. He cautions that these reductions are often cyclical and one or two individuals can dramatically cause an impact on Sea Pines' usually low crime rate.

It is the Security department's practice to discern when its crime reports reflect a pattern of similar geographic location and crime methodology that initiates a focused enforcement program. This process consists of gathering all pertinent data, analyzing the results and focusing the department's resources where they would most likely result in a successful closure. "A large part of this program involves community or organization involvement." The positive results are three-fold to residents:

- Knowledge alleviates fear.
- Provides the community a conduit through which they may participate.
- Assists Sea Pines Security with innumerable eyes and ears in the identification and arrest of the suspect.

"It is always important to remain alert throughout the year." With few exceptions, property thefts in Sea Pines are crimes of opportunity and access. These types of crimes include; an unlocked door, a key or access provided to a vendor when no one is at home, an open garage or items of value visible to the outside. Regardless of where you park your locked vehicle, never leave packages, golf clubs, cell phones, i-pod, purses or any valuable items in plain sight where a passing thief may be tempted.

Mr. Breed said funds have been budgeted for 2009 to supplement the existing audio/video camera systems at the gates. This security program will be expanded to include various locations throughout the community and has proven to be an invaluable tool in maintaining the "security" in Sea Pines.

"One of the many services that the Security department offers and some Sea Pines owners may not be aware of is a house check for absentee owners or owners who are on vacation." If you would like to have your home placed on the checklist, simply stop by or call 671-7170 and provide the dispatcher with the necessary information. The data is stored in our computer and checks are made on an irregular basis during the course of your absence.

He asked all owners to take pleasure in the safety and security of Sea Pines, but always remain vigilant to those who may wish to exploit careless opportunities. He also wanted to remind property owners that solicitation of any kind is not permitted in Sea Pines. If anyone should come to your door in an attempt to elicit contributions or work, try to note the person's description or type of vehicle and call Sea Pines Security immediately. He also requested property owners to keep parked vehicles in their driveway. This minor action could save a life in the event of a fire or medical emergency.

"Look out for your neighbor and always report **ANY** suspicious activity to the Security department immediately." The Security Dispatch office is always open and can be reached by calling 671-7170. •

FOR SAFETY'S SAKE - DO NOT STOP!

As the months progress, we see more people using our bike paths. In our effort to be genuinely courteous when driving, many people will stop their vehicle and encourage a bicyclist to cross the road.



Please DO NOT DO THIS unless a bike or

pedestrian is in the crosswalk. If you stop your vehicle and draw the person into the roadway, you may cause a rear-end collision and the possibility of contributing to a serious accident involving a vehicle approaching from the other direction. (SC Law \$56-5-3130. Right-of-way in crosswalks)

This encourages people to disobey stop signs and teaches children poor traffic safety rules as many children use these paths. Our own residents are as guilty of this as are the visiting tourists. •

BICYCLE RULES OF THE ROAD

- Night biking is dangerous and is not permitted in Sea Pines.
- Stay in single file on the right side of the path.
- Use of the road where a bike path exists, is prohibited by bikers, joggers, walkers and rollerbladers. (anything, but an automobile)
- Be considerate of pedestrians and warn them of your approach at least 50' away.
- Safety equipment such as helmets and horns/bells are recommended for bikers; helmets and kneepads for rollerbladers.
- Obey all state and local traffic laws, including the use of hand signals and observance of traffic signs.
- Guests who leave Sea Pines must obtain a pass code at the gate to gain re-admittance to the bicycle paths.
- Please refrain from riding on golf cart paths, racing, or high-speed operations.
- Motor Vehicles should never stop and wave a cyclist on as this will cause accidents.
- Use of paths in Sea Pines is limited to residents and guests.
- Riding on the beach is permitted, but please remember that sand and water could cause the bike chain to come off.

TOWER BEACH ACCESS

One of the jewels in the Sea Pines Crown is Tower Beach. Tower Beach was purchased to be used exclusively by Sea Pines Property Owners. This restriction is in effect year round, regardless of the presence of an officer.

There are 2 mechanisms in place for access: A valid property owner decal affixed to the correctly registered vehicle or the Sea Pines Property Owner Photo I.D. Card that is provided by Sea Pines Security. Please be sure that the ID card has the current year punched and remember that it is only valid when presented by the person to whom it is issued and who's photograph is reflected.

When your entire family is visiting and one vehicle doesn't accommodate all who are going to Tower Beach, the security officer will permit the property owner vehicle and one other vehicle (if is directly behind) access to the parking area. •
